- 1. THE STATE OF TOCANTINS has requested a loan from the International Bank for Reconstruction and Development (IBRD) to implement the Integrated Sustainable Regional Development Plan (PDRIS) and intends to apply part of proceeds for consulting services.
- 2. The purpose of this Request for Expressions of Interest aims to propose a landscape use planning, subsidize a policy of territorial planning, and organize operation bases of institutions for territorial management in Tocantins, through the partitioning of the State into landscape units aiming the elaboration of the Ecological-Economic Zoning of Tocantins. The expected duration of the contract is 24 months.
- The Secretariat of Planning and Public Management Modernization SEPLAN invites eligible consultants to submit an expression of interest in order to perform such consulting services. Interested consultants should demonstrate that they are qualified to carry out these services and should present documents that prove qualifications, capability and experience (printed, similar description of services, experience in similar circumstances, etc.). Consultants may create a consortium or an association with other firms to enhance their qualifications.
- 4. A consultant will be selected in accordance with procedures established by the World Bank's Guidelines for the Selection and Employment of Consultants by World Bank Borrowers, January 2011, Selection Based on Quality and Cost (SBQC).
