1. The State of Tocantins has requested a loan from the International Bank for Reconstruction and Development (IBRD) to implement the Tocantins Integrated Sustainable Regional Development Plan (PDRIS) and intends to apply part of proceeds of this loan to eligible payments for services of consultants to assist the Department of infrastructure - SEINFRA services in Environmental Supervision of works from CREMA in the State of Tocantins, as permitted in § 5 of art.42 of Law No. 8666 of 06/21/93 and subsequent amendments and related legislation.

2. The service is comprised of environmental supervision of the works of road rehabilitation under the CREMA program (*Contrato de Reabilitacao e Manutencao* – Rehabilitation and Maintenance performance based contracts). The scope will be rehabilitation phase of about 1600 km of state roads. The service will include monitoring of environmental performance in executing works and compliance with both the safeguard policy of the World Bank and social and environmental regulations. The expected duration of the contract is 51 months.

3. The Secretariat of Planning and Public Management Modernization (SEPLAN) invites eligible consultants to submit expression of interest in providing the consulting services. Interested consultants should provide information demonstrating that they have the qualifications, capabilities, and experiences to perform the services (brochure, description of relevant assignments and experiences, and etc.). Consultants may create a consortium or an association with other firms to enhance their qualifications.

4. A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers, January 2011.
