1. The STATE OF TOCANTINS signed a loan agreement with the International Bank for Reconstruction and Development (IBRD) for the implementation of the Integrated and Sustainable Regional Development Project (PDRIS), and intends to apply part of proceeds on eligible payments under consulting services contracts.
2. The services object of this request for expression of interest have the purpose of hiring specialized consulting services for the provision of technical services aimed at the improvement and systematization of routines related to the environmental management of the state road network, with its operationalization through the development of a computerized management system capable of organizing the internal processes, interacting with the geospatial database and with interoperability with field applications.
3. The Agencia Tocantinense de Transportes e Obras (AGETO) invites companies that are eligible to submit expressions of interest in order to provide such consulting services from which the following results are expected to be achieved: analysis of the administrative processes of the Diretoria de Viabilidade Ambiental (DIVAM) , identifying overlaps, rework, waste of time and resources, conflict of competence, and other structural bottlenecks; to propose and implement improvements in the management of operational and strategic processes of that Diretoria, through the development and implementation of technological tools, aiming at the environmental management of the road network of Tocantins State.
4. Interested Companies and/or Institutions shall demonstrate their qualifications to perform the services and shall provide information that demonstrates specific qualifications, skills and experience. The criteria to select companies will mainly observe: (i) previous experiences in diagnosis for restructuring processes through the implementation of technological platforms; (ii) development and implementation of a computerized system for the management and monitoring of environmental conditioners; (iii) experience in projects environmental management and in the analysis and development of tools for environmental management; (iv) experience in the region and/or in Brazil. 5. The establishment of a consortium or an associations is encouraged to reinforce the required qualifications.
6. A company, institution or association will be selected according to the procedures established by the World Bank Guidelines for the Selection and Employment of Consultants by World Bank borrowers from January 2011 through the Quality and Cost Based Selection (SBQC).
