1. The STATE OF TOCANTINS has requested a loan from the International Bank for Reconstruction and Development (IBRD) for the implementation of the Integrated Sustainable Regional Development Project - PDRIS and intends to use part of the resources of this loan for valid payments for Consulting Services.
2. The object of this request for expression of interest is the hiring of specialized consulting services to elaborate pilot study of risk assessment of agro-toxin contamination in the *Formoso* irrigation perimeter, Municipality of *Formoso do Araguaia* – TO, through ecotoxicological tests, in order to provide support for the implantation of a control system and monitoring the use of agrochemicals in the perimeter. The study should be guided by the provisions: (i) CONAMA Resolution No. 420 of December 28, 2009, and subsequent amendments; (ii) CONAMA Resolution No. 357 of March 17, 2005, and subsequent amendments; (iii) of the Normative Ordinance IBAMA No. 84, of October 15, 1996; (iv) Federal Decree No. 4,074, of January 4, 2002; and (v) the World Bank's Pest Management Safeguard Policy (OP 4.09). The scope of the services includes: **(a)** Data Collection of the main pesticides used in the irrigated perimeter ; **(b)** risk assessment, which includes: hazard identification, risk analysis including: the exposure (water analysis, sediment analysis, soil analysis and isotopic analysis) and characterization of the effects ( ecotoxicological tests) ; and **(c)** Risk Management Plan,
3. The Secretariat of Finance and Planning - SEFAZ invites eligible consulting firms to present their expression of interest in order to perform the aforementioned consulting services. Interested companies should provide information indicating that they are qualified to the services. The criteria for selecting the short list are: **a) experience in environmental risk assessment in agricultural areas; b) experience in ecotoxicological tests; c) experience in environmental risk management of agricultural areas;**
4. The consortia implementation and associations for the purpose of reinforcing qualifications to be informed is hereby accepted.
5. The expressions of interest of interested consultants are required under paragraph 1.9 of the Guidelines for Selection and Hiring of Consultants granted under IBRD loans and AID Credits & Grants by the World Bank borrowers, version of January 2011, ("Consultants Guidelines"). The consultants will be selected according to the procedures established by the World Bank Guidelines for the Selection and Hiring of Consultants by World Bank borrowers, January 2011. The method used will be the Selection Based

on Quality and Cost (QCBS).
